Conditions of Entry

1. **ALLOCATION OF SPACE:** No space will be allocated until completed entry form with appropriate fee and certificate of insurance has been received. Stands will be allocated on first come first served basis and decision of steward is final.
2. **INSURANCE:** All Exhibitors must have Public and Employers Liability. Policies must be extended to indemnify Kildare County Show Society Ltd., its agents and servants against any claim whatsoever that may arise for the duration of the Kildare Show.
3. **LOSS AND DAMAGE:** Kildare County Show Society Ltd., will not be responsible for breakage, damage or loss arising from any source whatsoever. Each Exhibitor should have adequate insurance cover in respect of property, employee and third party liability, and such cover shall indemnify Kildare County Show Society Ltd. in all respects whatsoever. In particular exhibitors of machinery which could cause injury when in motion or otherwise are required to have adequate safeguards in place to protect the public and especially children.

Exhibitors should note the Kildare County Show Society Ltd., its agents or servants shall not in any way be responsible or accountable to exhibitors, personnel, visitors to exhibitors stands, or exhibitors property on any part of the Show Grounds.
4. **SECURITY ON SITE:** Kildare County Show Society Ltd. will provide security for day and night duty, but will not be responsible for any loss of equipment or other items from stands.

5. **SUB LETTING:** No sub-letting permitted by any Firm or Company without permission from the Organisers.
6. **CANCELLATION OF BOOKING:** No stand cancellation can be entertained after Saturday 11th June, 2011.
7. **ENTRY and DISMANTLING OF STANDS:** All equipment must be on stands by Saturday 18th June, 2011. No stand can be dismantled before 5.30p.m. on Sunday 19th June, 2011.
8. **BANNERS:** The display of banners and other advertising material permitted on your stand only. No banners can be displayed outside marquees without prior consent.
9. **LITTER and ANNOYANCE:** You are obliged to keep your stand free of litter during the Event, numerous skips will be on site. No exhibitor will be allowed to cause any annoyance to his/her neighbouring exhibitors by using a public address, loud music or excessive noise of any kind, or distribute any material which may cause annoyance.
10. **REJECTION OF APPLICATION:** The Kildare County Show Society Ltd. reserves the right to reject an application for exhibition space, to reduce Trade Stand ground allocations, withdraw permission to exhibit, or close down an exhibition stand.
11. **GROUNDS:** Exhibitors wishing to drive stakes etc. into the ground must consult the grounds committee before doing so, as the stand space is located on Sports fields and any interference may damage the playing surface.
12. **PASSES:** One vehicle and two exhibitor passes will be allocated.
13. **EXCLUSIVITY:** No exhibitor will be permitted to demand exclusive right of sale for a particular product at the event unless the exhibitor has the patent on the said product.
14. **CANCELLATION OF EVENT:** Kildare County Show Society will not be responsible to any exhibitor or person for any loss of profits, consequential loss, or any loss whatsoever, arising by reason of the cancellation of the event.
